About Us

The Battlefords Interval House Society Inc. is a community-based non-profit, charitable organization which provides provide 24-hour emergency safe shelter and support for women and those with accompanying children leaving circumstances of violence and abuse. The shelter also provides services which may include crisis intervention, emotional support, safety planning, childcare, transportation, public education, and advocacy.

Battlefords Interval House is a 15-bed facility (6 rooms) and has the capacity to accommodate 19 residents.

Our Mission

To work towards the elimination of violence by providing safe shelter, empowerment, support, education and guidance to women and their children in crisis.

Our Values

Battlefords Interval House believes in providing a safe, respectful environment for women and their children experiencing violence.

Our Goals

- To provide safe, secure housing for women in crisis
- To provide information and support to women in crisis
- To provide advocacy to women and children
- To build opportunities for self-help leading to empowerment

Message from the Executive Director

When I hear the phrase 'women's shelter' the first thing that comes to mind is 'resilience'. Resilience of the women and children who utilize the Battlefords Interval House (BIH) services. These women come from all walks of life, but one common denominator is they all have come from violence and trauma. Their stories will vary, their pain will vary, but why they have come to BIH is the same. They all have no place left to turn; no place left to go. Often it takes their last molecule of energy, courage, to ask for help. These women amaze me!

Four decades is how long BIH staff, volunteers and the board of directors have devoted themselves to supporting women and children fleeing intimate partner violence and abuse. This service has remained steadfast over the many years. We provide emergency housing, food and clothing, emotional support, advocacy, and education. We provide education to our community and surrounding areas to help spread the word that violence kills, but there is support and hope for a violence free future.

Staff at BIH are available 24-hours a day, 7 days a week. There is always someone available to pick up the crisis line call and be there for someone. For the duration of our clients stay, they have access to various in-house programs and to our various community partners' programs. The relationships we develop with many community members, local businesses, and other agencies are all necessary for the success of our agency. They say it takes a village, and that is true in our case.

Another intricate part to this village is the incredible employees. Listening, being professional and supportive is part of the work they do. But internally they have heard about the violence and the trauma, thus they must find their own ways to digest this information. They do this 365 days a year. They are to be commended!

The last part to our village is the ongoing generous support we receive from the Saskatchewan Ministry of Justice, service clubs, churches, local and distant businesses, other not-for profit agencies, and of course all those many private individuals who consistently donate money and supplies to support women and children of the Battlefords and area. We are forever grateful to all who lend us their support.

The end of our fiscal year brought many new challenges with the onset of the COVID-19 pandemic. These are uncharted waters we sail, but the village has pulled together yet again. Support and guidance from the board of directors, the Ministry of Justice, the Provincial Association of Transition Houses and Services, Women's Shelters Canada, many businesses, organizations, and the community have all helped us to be resilient. Resiliency the common denominator for us all!

- Improve Executive Director access to Battlefords Interval House financial records for timely financial management and risk mitigation purposes.


Tactics - Year 2 (2020-2021)



Budget in Brief



Program Report

24-hours/7 days a week support service is available to women and children of the Battlefords and area. This includes providing service to in-house clients, as well as telephone and website support for clients that are reaching out for assistance through these avenues.



The staff at Battlefords Interval House make every effort to provide relevant information and education to our clients about healthy relationships. We believe education and community involvement are integral to ending violence.

Here are some of the various community activities clients were able to participate in:

Community Partnerships

As we become more deeply connected with community programs and services, we offer our clients much more together than we ever could on our own. Strengthening community partnerships help to create a well-linked system – expanding options and support for women and their children as follows:

- Catholic Family Services of the Battlefords Inc. and Battleford's & Area Sexual Assault Centre Inc. each provide one educational group session per week at Battlefords Interval House.
 - Catholic Family Services deliver group support in areas such as: family violence, therapy for healthy relationships, grief/loss, disordered eating, etc.
 - Battleford's & Area Sexual Assault Centre Inc. deliver group support for survivors of sexual assault and/or abuse.
- Our staff assist with client referrals to the appropriate community agency (e.g. mental health, substance abuse, educational, family counselling) for clients who require additional external support.
- Battlefords Interval House joined with the Mental Health Capacity Building Initiative (Living Sky School Division and Light of Christ School Division) and Catholic Family Services Inc. to host their annual event on Wednesday December 6, 2019 to commemorate the *National Day of Remembrance and Action on Violence against Women*.



Debbie Kovalsky of Battlefords Interval House, Mandy Melanson of Catholic Family Services of the Battlefords, as well as Erin Woytiuk with Mental Health Capacity Building Initiative led the vigil.

- Battlefords Interval House initiated an ongoing working partnership with North Battleford Housing Authority (NBHA) and developed an application process for our clients to their agency that is streamlined, efficient and less 'wait' time for housing. When the pandemic unfolded in March 2020, a new process was implemented.

Meet Jade

'Interval', a space of time between events, a moment in time! For a moment in time we offer a warm clean bed, cupboards full, bills paid, a peaceful violence free and stable home to women and children of the Battlefords and area. For a moment in time, we offer a refuge from someone's worst nightmare. When I speak of 'someone's worst nightmare' for many that could be a life-threatening medical diagnosis like cancer, but for many women and children, it is life threatening violence they are experiencing! Battlefords Interval House offers a moment in time for peace.

Meet Jade, she was a little shell of a woman, bruises filled the round of her eye and the back of her hand where she tried to protect herself. She brings her children and herself from her community, the place she had lived all her life. She leaves behind everything she has; her belongings, her clothing, her identifications, her extended family, everything! She also leaves her husband, to come to Battlefords Interval House for a moment in time, for rest from the violence of her husband. While at Battlefords Interval House she is offered the basics of life, food, shelter, and clothing. But what is more, she is offered the moment in time to find herself again. She is given the peaceful space to be able to think for herself, the support to work through the trauma her and her children just experienced. They are offered time to heal from their worst nightmare.

While with us at Battlefords Interval House, Jade was given the support to start over. Can you picture yourself starting over? We supported her to register her children in school, re-apply for her identifications, get her tax returns from Revenue Canada, apply for low income housing, and apply for Saskatchewan Income Support. She was supported to pursue counselling for herself and her children to work through the trauma they endured for many years. She healed from her external bruises and began the process to heal from her internal bruises. We watched her children change from being withdrawn and aggressive to their mother, and to one another, to becoming little people who were happy, smiling and cooperating with their mom. We watched Jade grow from a little shell of a women to a self-supporting and confident woman and loving and caring mother. Jade qualified for Saskatchewan Income Support (SIS) and lowincome housing. She was fortunate to receive some free furniture and household items to start over.


Jade is the statistic, she left her husband, her abuser for good on her seventh time leaving. Battlefords Interval House offered her that moment in time to find her way, to find her inner strength to grow. To find her person who she used to be before the abuse and the damage to her inner spirit. She was given the life saving time needed to regain her strength, to find hope for a better tomorrow.
